#### [The EU Health Technology Assessment and the Open Method of Coordination: A Relation with Potential in the Context of Network Governance](#)

The open method of coordination (OMC)—a tool which was formalized in the early 2000s— has generated the interest of both the researchers and practitioners in the context of the new EU governance. This article is examining the literature of both network governance and OMC, with the focus particularly on one main question: is OMC a useful instrument in health policies in order to achieve concrete results by outlining norms and legislation where EU exercise limited power? Analyzing a field in which the EU competence is limited—given the budgetary implications of medicines reimbursement—from the results of the existing collaboration within EUnetHTA, we will observe the added value in this particular case of the OMC application, and the possible consequences in shaping the supranational competences. Given that the EU, with some exceptions provided by the Treaties, may only exercise actions to support, coordinate or complement the action of the Member States in the health policy, the OMC proves to be a useful tool, both from the perspective of the Member States but especially of the supranational level

#### [Does the European Governance strengthen as a result of the reform process adopted by the Treaty of Lisbon?](#)

– 2020

The importance of the Lisbon Treaty has been and is still widely debated in the academic environment. The insufficiency of the European Union model required adapting the Union to the reality of a 27 members that

would bring it closer to its citizens, deepen democracy, increase efficiency and prepare the EU for the future as a global player. The discussion about governance arises in this context of the need to increase the transparency of the decision-making process and the implementation of public policies in a Union with different levels of decision-making. The objectives of ensuring the connection of citizens with democratic institutions so that they feel represented was an initial condition for more relevant and effective policies. In this article, I intend to first analyse the concept of governance and then I will focus on the mechanisms by which it has been strengthened once the new provisions of the Lisbon Treaty were implemented, with an emphasis on citizens' initiative, the role of national parliaments, the role of regions and local authorities, finally presenting the figures from the end of 2019 that show the confidence of citizens in the EU, compared to 2009 before the reform. We will see that more than 10 years after the entry into force of the Lisbon Treaty, citizens' confidence in the EU reaches a modest threshold of 43% and 2% higher when it comes to democracy - 45% of citizens agree that their voice matters in the EU

### **The Subsidiarity Principle and National Parliaments Role: From Formal Need to Real Use of Powers** – 2020

Subsidiarity constitutes a guiding principle of the EU exercising power and the idea of involving national parliaments in the EU legislative procedure was seen as the best solution to increase democracy and transparency of the EU decision-making process at the European Convention established in 2001. Such a mechanism enables national parliaments to ensure the correct application of the principle of subsidiarity by the institutions taking part in the legislative process. This article examines how this principle is implemented by the national parliaments and EU responsible institutions. What is the novelty derived from the Treaty of Lisbon? Do national parliaments participate actively in the implementation of subsidiarity? If yes, what are the tools at their disposal? To answer all of these questions we try to shape a framework for understanding the phenomenon.

### **The Idea of a European Union in the Interwar Period** – 2020

The study of the political history of European construction is particularly important to explain the context in which the first institutional nuclei of European integration appeared. This paper identifies the main contributions from the interwar period to the project of a united Europe and their role in defining the process of creating the future European Union. The paper analyzes two main federalist projects namely "Pan-Europe" and "Briand initiative", looking at the similarities between them and at the elements prefigured by the two Europeanists of the federalist movement which are found in the current political-institutional configuration of the European Union. I conclude that Coudenhove-Kalergi and Aristide Briand's proposals still represents, after 90 years since their drafting, core principles and values we recognise today in the European Union of 2020.
